KID'S FIRE CAMP RELEASE, WAIVER  
AND INDEMNIFICATION FORM**

WHEREAS, the Wentzville Fire Protection District believes that educating the children of our District on fire prevention serves the greater benefit of the minor children in this District with not only becoming familiar with the day to day operations of the Firefighters but in better protecting themselves and preventing dangerous situations. In consideration thereof, and in furtherance of allowing such participation in the Kid's Fire Camp program, the undersigned does hereby agree to the following:

I, \_\_\_\_\_ the parent or legal guardian of \_\_\_\_\_, not being a sworn member, employee or agent of the Wentzville Fire Protection District, have made a voluntary request for permission for my child to participate in the Wentzville Fire Protection District's Kid's Fire Camp; and

On behalf of myself and child, my successors, executors, assigns and heirs, for and in consideration of the Wentzville Fire Protection District allowing my child to participate in the District's Kid's Fire Camp program do hereby agree to release, indemnify and hold harmless the Wentzville Fire Protection District, its officers, agents, volunteers and employees from any and all liability, loss, claims and demands, actions or causes of action (in law or equity) for any injury or injuries of any nature that I may sustain or incur arising out of any act, occurrence, accident or condition during the period I am so participating in the program and observing operations and facilities of the Wentzville Fire Protection District. This release and waiver includes, but is not limited to, waiver of all claims, suits and causes of action based upon negligence or tortuous act or conduct by the Wentzville Fire Protection District, its officers, agents, volunteers and employees. I realize that by virtue of this provision, I am waiving specific rights of recovery for injuries or damages which I may suffer and other rights which I may have knowingly done so by execution of this release and waiver.

On behalf of myself and child, my successors, executors, assigns and heirs, for and in consideration of the Wentzville Fire Protection District allowing my child to participate in the District's Kid's Fire Camp program do hereby agree to indemnify, defend and hold harmless the Wentzville Fire Protection District, its officers, agents, volunteers and employees from any and all liability, loss, claims and demands, actions or causes of action (in law or equity) for the death or injury to any person(s) and for any property damage sustained or incurred by any person which arises or may arise or be occasioned in any way from any act, occurrence, accident or condition caused by my child during the period my child is so participating in the program and observing operations and facilities of the Wentzville Fire Protection District.

I do hereby authorize the District to seek emergency medical treatment in case of injury, accident or illness. I understand that I will be responsible for medical costs incurred by such injury, accident or illness.

I do hereby authorize the district permission to use my or my child's photograph publically to promote the library. I understand that the images may be used in print publications, online publications, presentations, websites, and social media. I also understand that no royalty, fee or other compensation shall become payable to me by reason of such use.
